The following definitions are not used within the agreement so can be removed - KVAr, KVArh, KW, KWh, Line Loss Factor, Line Loss Factor Class, Profile Class, Settlement Administration Agent, Unmetered Connection Agreement.

The cross references in the following definitions have been altered or can be more specific as follows:

Change Register has the meaning given to that term in Clause 11.245. **Initial Account** has the meaning given to that term in Clause 20.3.

Late Payment Notice has, in respect of Section 2A, the meaning given to that term in

Clause 23.2, and, in respect of Section 2B, has the meaning given

to that term in Clause 46.2.

Payment Default has, in respect of Section 2A, the meaning given to that term in

Clause 23.1, and, in respect of Section 2B, the meaning given to

that term in Clause 46.1.

3. (Housekeeping Log ref 21) Amend Clause 18.2.2 as follows:

18.2.2 the Company receiving confirmation that an Accredited Meter Operator Agent, Accredited Data Collector and Accredited Data Aggregator (where that Exit Point or Entry Point relates to a Metering Point) or an Accredited Meter Operator Agent (where that Exit Point or Entry Point relates to a Metering System) have been appointed (except that no Meter Operator Agent is required to be appointed in relation to an Unmetered Supply);

4. (Housekeeping Log ref 24) Amend Clause 34.2.3 as follows:

- (D) information which the Company or any Affiliate or Related Undertaking of the Company (as the case may be) is required or permitted to make disclosure of:
 - (E) (i) in compliance with the duties of the Company or any Affiliate or Related Undertaking of the Company (as the case may be) under the Act or any other requirement of a Competent Authority;
 - (F) (ii) in compliance with the provisions of any Relevant Instruments;
 - (G) (iii) in compliance with any other requirement of law;
 - (H) (iv) in response to a requirement of any Stock Exchange or the Panel on Takeovers and Mergers or any other regulatory authority (whether or not similar to those bodies); or
 - (I) (v) pursuant to the arbitration rules of the Electricity Arbitration Association or pursuant to any judicial or other arbitral process or tribunal of competent jurisdiction; or
- (J) (E) in the case of information falling within Clause 34.1.2, to the person who supplied electricity to the relevant Customer or purchased electricity from the relevant Generator at the time at which such information was acquired by the Company; and

5. (Housekeeping Log ref 15) Update Event Log:

Amend the reference to clauses 30.5 & 30.9 in the Event Log – This currently references DO135, it should be changed to read $\frac{D0135}{D}$

This DCP seeks to bring some of those changes into DCUSA in order to ensure that the DCUA drafting is improved and to manage the housekeeping process.

It is hoped that by focussing on those housekeeping changes that relate to Part 2 clauses the change process will be shorter and enable it to be ready for a June implementation.

Changes to definitions have been included as Part 2 which have been deemed to not <u>materially</u> affect the interpretation of any Part 1 Clauses.

Part 1 changes and any further Part 2 changes will be raised separately.
