Justification for Part 2 Matter

2.1 The Panel reviewed DCP 310 and noted that the Proposer's opinion was that the change should be treated as a Part 1 matter. The Panel considered the change to be a formality and there is no reason for the Authority to make a final decision. It was also agreed that as the change is being progressed to the Change Report stage there is no need for it to be considered to be an Urgent change and will most likely be presented to the Panel for approval at their October meeting.

2.2 The Panel considered that the Proposer has carried out the level of analysis required to enable Parties to understand the impact of the proposed amendment and to vote on DCP 310.

2.3 The DCUSA Panel recommends that this CP:

3 Why Change?

Background of DCP 298

3.1 The ENA is moving offices over a phased period. Post will be redirected. Supplier contracts are obliged, via Schedule 2A, to direct customers to methods by which they can obtain the NTC and writing to the ENA is one of them. The address is also quoted in Schedule 2C. Therefore, the address should be updated.

4 Solution

DCP 310 Assessment

- 4.1 The DCUSA Panel recommended that the CP be progressed to the Change Report Phase.
- 4.2 This change seeks to amend Schedules 2A and 2C to quote the new address.
