It can be seen in the table above that the services to support industry arrangements are almost always provided by the DNO (or IDNO for IDNO sites).

It can also be seen that the PNO provides asset on PNO sites with the only other service being optional Use of System (UoS) charging to the end-customers supplier. where there are settlement meters on the PNO site a charging methodology is required, and needs to be approved by Ofgem.

In the BNO model the BNO's also have the option for charging BNO UoS.
