1. Welcomes and Apologies

1.1 The Secretariat noted the welcome and apologies for this meeting.

2. Administration

2.1 The Working Group reviewed the “*Competition Law Do’s and Don’ts*”. All Working Group members agreed to be bound by the Competition Laws Do’s and Don’ts for the duration of the meeting.

2.2 The Group approved the minutes from the last meeting as an accurate depiction of the discussions held.

- 2.3 The Chair noted that Andrew Conway will be replacing Tim Aldridge as the Ofgem representative for the DCP 312 Working Group meeting.

3. Purpose of the Meeting

- 3.1 The Secretariat set out that the purpose of the meeting is to review the DCP 312 draft Consultation Document.

4. Working Group review of DCP 312 Draft Consultation Document

- 4.1 The Working Group walked through the draft DCP 312 Consultation Document and as a result of these discussions, the Working Group agreed to the following consultation amendments:
- It was noted that both DNOs and EDNOs are experiencing issues with this change and Clause 1.3 was updated to reflect this;
 - Throughout the document, the phrase 'bill' was replaced with 'invoice' for clarity;
 - ;
 - Clause 5.4 was re-worded for clarity regarding the removal and addition of data in circumstances of issuing re-bills; and
 - Question 3 'Can you support both options?' was updated, requesting an impact assessment from respondees.
- 4.2 One Working Group Member suggested only having one solution in the consultation may be prudent, as they believed that the second proposed option that would spread consumption data over all MPANs for a multi-MPAN site may incur costly system changes. The Working Group agreed that this consultation would allow respondents to give their views on whether this is the case, and the Working Group will continue their development of the proposal based on this feedback.
- 4.3 The Working Group were reminded that if the option chosen by the Working Group was not acceptable to a member of the Working Group, they could raise an alternative and since this is a Part 1 matter, both would be submitted to the Authority for their decision after the voting phase.
- 4.4 The draft consultation document with Working Group comments can be found as Attachment 1.

Legal Text Review

- 4.5 The Working Group reviewed the proposed legal text and agreed that it was fit for purpose. The difference between both options being in the spreadsheet template.
- 4.6 The spreadsheet was reviewed and minor changes proposed to improve the clarity of both options.

5. Work Plan

- 5.1 The DCP 312 Working Group reviewed the Work Plan and made a number of amendments. This has been included as Attachment 2.

6. Next Steps

- 6.1 ElectraLink agreed to an action to update the draft Consultation Document as a result of today's discussions and circulate this to the Working Group.
