1. Administration

- 1.1 The Chair welcomed the members to the meeting.
- 1.2 The Working Group reviewed the "Competition Law Do's and Don'ts". All Working Group members agreed to be bound by the Competition Laws Do's and Don'ts for the duration of the meeting.

2. Purpose of the Meeting

- 2.1 The Chair set out that the purpose of the meeting is to review the Ofgem send back letter for DCP 295 and agree the next steps for the change.

3. Review of DCP 295 Authority Send back letter

- 3.1 The Working Group reviewed the DCP 295 send back letter which can be found as Attachment 1.
- 3.2 The Chair discussed the basic outline of the Authority's send back letter and explained that their main focus was that the Working Group had not consulted with enough impacted Parties for the Authority to be able to make a decision on the change.
- 3.3 One Working Group member highlighted that the Working Group cannot force Parties to respond to their consultation but agree that Working Group members should make a further effort to engage.
- 3.4 One Working Group member questioned whether ElectraLink had sent the original consultation to any generation trade organisations and if not, it would be beneficial to do so this time. It was also suggested that the consultation should be sent to ELEXON and ask them to send out to their BSC Parties again.
- 3.5 One Working Group member suggested that when they update the Change Report, the Working Group should try to detail all impacts on CVA Registrants, including why there would be a phased implementation with the DCUSA Code changes being made in advance of the National Terms of Connection (NTC) changes, as this will depend on whether the CVA Registrant is signed up to the NTCs and would depend on their Bilateral Connection Agreement that they have in place with the DNO. It would also be beneficial to state any minor impacts, i.e. whether there would be any financial impacts.
- 3.6 The Chair suggested that the original consultation should be updated to include a short paragraph to explain why the Working Group are consulting again. Once the responses have been received the Working Group can meet again to review the consultation responses and can update the Change Report to demonstrate that the Working Group have taken the Authority's send back letter into consideration.
- 3.7 The Working Group also agreed that each DNO should forward the consultation document to each of their CVA Registrants and connectees. The Working Group requested that the Secretariat request that the DNOs who are not members of the Working Group do the same.
- 3.8 The Secretariat agreed to update the consultation document and circulate to the following Parties:
 - DCUSA Contract Managers;
 - BSC Code Administrator (to request to send to their Parties);
 - The Association for Decentralised Energy;
 - Scottish Renewables;
 - Solar Trade Association; and
 - Renewable Energy Association.
