1 ADMINISTRATION

- 1.1 The minutes of the last meeting were approved with minor amendments.
- 1.2 The group reviewed the open actions. Updates on all actions are set out in Appendix A.
- 1.3 The Working Group noted that BW would not attend the remainder of the DCP 172 Working Group meeting as he considered the DCUSA process to be flawed in regards to its voting procedure. BW requested the Working Group to place the change on hold until the voting procedure could be fixed to include those members impacted by the Common Connection Charging Methodology (CCCM) changes in particular customers and developers.
- 1.4 The Working Group noted that the DCP 172 change had been raised due to the outcome of a determination and that there is an expectation from Ofgem ~~and the DCUSA Panel~~ that this change will be progressed. Any issues that BW considers have been identified in the voting process are outside of the scope of the Working Groups role in this change.
- 1.5 Members also noted that the if a change was to be raised to the DCUSA voting process that it would take a significant period of time before it could take affect.

- 2.1 The Working Group reviewed the Working Group comments on the DCP 172 consultation document.
- 2.2 NM agreed to further review the comments and provide a revised consultation document to the Working Group for agreement.
