This was raised due to a part omission (by DCP011) on this clause (i.e. the first part of the change is in DCP011 but not the second part). It is therefore recommended that this change is applied first and then DCP011 (but still as part of the same release) to ensure the correct outcome to this clause and avoid any 'unpicking' that may occur should the changes be applied in reverse.
			Housekeeping number four is linked to DCP012. This change proposal highlighted the need to amend this clause within Section 2A because Clause 50.2.4

			was structured differently but based on the same clauses.
			As a consequence of this, there is a further consequential housekeeping change to Clause 34.2.4 which currently refers to Clause 34.2.3 (A), (B) and (E). Clause 34.2.4 (E) will now form part of Clause 34.2.3 'D' with 34.2.3 (J) now becoming 34.2.3 (E) so this clause will need to be amended if this change proposal is successful.
			However, prior to determining the change, we should also check Clause 50.2.4 which does not have such a reference (i.e. only refers to Clause 50.2.4 (A) and (B))
