

**DCP382 – Amendment to the Electricity Theft Detection Incentive Scheme (ETDIS) Timing**

**Draft Legal Text**

**Amend paragraph 1.3 in Schedule 30 of the DCUSA as follows:**

- 1.3 The Scheme applies by reference to successive periods of 12 months starting on 1 June 2018 (with each 12-month period forming a "**Scheme Year**"). The first Scheme Year will commence on 01 June 2018. Given that the Theft Risk Assessment Service Arrangements under this Agreement are due to be migrated into the Retail Energy Code with effect from 1 April 2021:
- (a) Scheme Year 3 will run for 8 months from the beginning of 1 June 2020 until the end of 31 March 2021;
  - (b) Scheme Year 4 will run for ~~14-12~~ months from the beginning of 1 ~~February-April~~ 2021 until the end of 31 March 2022; and
  - (c) subsequent Scheme Years will be for successive periods of 12 months following the end of Scheme Year 4.

**Amend paragraphs 3.7B in Schedule 30 of the DCUSA as follows:**

- 3.7B For Scheme Year 4 (SY4), the Theft Targets will be based upon a total of ~~39,667~~34,000 Confirmed Theft detections in aggregate across both market sectors; with a specific breakdown of ~~35,000~~30,000 Confirmed Theft detections for the Residential Sector and ~~4,667~~4,000 Confirmed Theft detections for the Commercial Sector.

**Amend paragraph 5.3 in Schedule 30 of the DCUSA as follows:**

- 5.3 Based on the formula set out in Paragraph 5.2, the size of the individual incentive pots for the Residential Sector and Commercial Sector for each of SY1, SY2, SY3 and SY4 will be as follows:

Residential Sector Incentive Pot: £12m (30,000 x £400)

Commercial Sector Incentive Pot: £1.6m (4,000 x £400)
