#### Part One: General (Open Session)

#### 1. Administration

- 1.1 The Chair welcomed all attendees to the meeting.
- 1.2 Apologies were noted from Simon Yeo and Karl Maryon.
- 1.3 The minutes of the last meeting were reviewed, and it was agreed they were an accurate representation of the meeting.
- 1.4 The Panel reviewed the open actions and updates on all actions are set out in Appendix A.

## 2. Updates from Industry Codes

#### **Balancing & Settlement Code (BSC)**

- 2.1 MDW presented a brief verbal BSC update.
  - P429 'Switching off Participant-Reported PARMS Serials' is currently with the Authority awaiting decision.
  - <u>P300 'Formal title: Introduction of new Measurement Classes to support Half Hourly DCUSA Tariff Changes (DCP179)'</u> was implemented on 8<sup>th</sup> December 2021.
  - <u>P432 'Half Hourly Settlement for CT Advanced Metering Systems'</u> has recently been raised and the first Working Group meeting is planned for January.

#### Ofgem

- 2.2 NH provided an update on DCPs with Ofgem for decision, during which the following was noted:
  - The Authority expects to make a decision on <u>DCP 375 'Amendments to the Unmetered Supplies National Terms of Connection'</u> and <u>DCP 383 'Provision for Distributors to Move Meters for Service Alterations'</u> on 15 December 2021.
    - The Authority expects to make a decision on <u>DCP 297 'Network Interventions SLA</u>

      Enhancement' by the end of January 2022.
  - The following DCPs remain deprioritised:
    - DCP 313 'Eligibility Criteria for EDCM Generation Credits'
    - DCP 343 'Use of a nominated calculation agent for the calculation of the LV mains split'

#### **Post Meeting Note:**

DCP 375 and DCP 383 were both approved by the Authority for implementation. Both CP's will be implemented into DCUSA on 24 February 2022.

#### SEC

2.4 There was no update provided by SEC. AF took an action to contact SEC, along with REC to see if there was an appetite for updates to be provided to the DCUSA Open Panel.

## 3. Accession Applications

- 3.1 AF presented the Accession Applications paper to the Panel, which had been circulated prior to the meeting. See paper (Panel\_2021\_1215\_01)
- 3.2 AF confirmed that there was one accession to be approved by the DCUSA Panel this month, shown in the table below. The Panel approved the Accession Application and instructed the Secretariat to proceed with drafting and issuing Accession Agreements for the Applicant below:

### 4. DCMDG Headline Report

- 4.1 AF provided a verbal update with respect to the DCMDG meeting held on 18 November 2021. Key updates were:
  - DCP 395 'Allocation of Smart Meter Communication Licence costs within LDNO Tariffs' has been raised. DCMDG members were encouraged to join the Working Group as it has not yet received sufficient representation to progress.
  - It was noted that one DNO member explained that they had originally identified sites which they believed should be classed as Non-Final Demand sites and had been expecting to be in receipt of certification from Suppliers for those sites but that certificates had not yet been received for some sites. It was noted that communications regarding this had been sent to the customers of those sites and Suppliers and that if certificates were not received by the end of November 2021, those sites will need to be classed as Final Demand for the purposes of 2023- 24 tariff setting.
- 4.2 The Panel noted the verbal update.

## 5. CACOP Headline Report

5.1 RC provided a verbal update with respect to the CACoP meeting held on 13 December 2021. The key update is:

- The BSC and REC intend to issue an RFI to determine whether there is a benefit to investigating an industry aligned Release date. The REC Release date is transitioning from a Thursday to a Friday from November 2022.
- 5.2 The Panel noted the verbal update.

## 6. DCUSA Monthly Horizon Scan

- 6.1 AF presented the DCUSA Monthly Horizon Scan to the Panel, which was circulated prior to the meeting. See paper (Panel 2021 1215 02).
- 6.2 AF advised that no significant updates have been made in the past month.
- 6.3 The Panel noted the contents of the Horizon Scan.

## 7. Change Register

- 7.1 AF presented the Change Register updates to the Panel, which had been circulated prior to the meeting. See paper (Panel\_2021\_1215\_03).
- 7.2 The Panel noted the contents of the Change Register.

#### 8. Initial Assessments

- 8.1 AF presented the Initial Assessment Cover Paper to the Panel, which had been circulated prior to the meeting. See paper (Panel\_2021\_1215\_04). It was noted that there was one new Change Proposal presented for Initial Assessment by the Panel as follows:
  - DCP 398 'Gender Neutral Amendments to the DCUSA'
    - It was noted that the intent of this Change Proposal is to remove any gendered language used throughout the DCUSA and replace it with gender neutral language to ensure that the drafting reflects a more diverse and inclusive approach.
- 8.2 For DCP 398 the DCUSA Panel:
  - ACCEPTED the referral of the CP;
  - AGREED that the CP should be treated as a <u>Standard</u> change;
  - AGREED that DCP 398 should be treated as a Part 2 Matter;
  - AGREED that DCP 398 will be progressed to the Change Report phase; and
  - **AGREED** the progression of the CP will be in accordance with the timescales set out in the table under paragraph 3.1 of the paper.

- 9.2 For the DCP 396 Change Report, the DCUSA Panel:
  - DETERMINED that the Change Report contained the level of information required to enable Parties to understand the impact of the proposed amendment and to vote on the Change Proposal;
  - **DETERMINED** that the Parties eligible to vote on the Change Proposal are those Parties that are impacted by the Change;
  - **DETERMINED** that the voting period for the Change Proposal should be set to 15 Working Days; and
  - APPROVED the Change Report for issue to Parties on 17 December 2021.
