## 1. Administration

---

- 1.1 The Working Group reviewed the “Competition Law Guidance” and “Terms of Reference”. All Working Group members agreed to be bound by the Competition Law Guidance for the duration of the meeting and agreed to the Terms of Reference.
- 1.2 An action log has been created and all updates are provided in **Appendix A**.

## 2. Review of Q&A Briefing Session

---

- 2.1 The Working Group discussed the questions and answered that were raised within the Q&A session for DCP 406/407 held on 30 August 2022.
- 2.2 BH mentioned that discussions around EVs were raised at the Q&A session around whether battery storage should be treated as generation. Those with battery storage currently have a clear policy position, however if there are EVs that are going to be from vehicle to the grid and they have some provision to export, is there any point in which they become something other than demand connection?
- 2.3 DB added that this is a point that will need further consideration and focus on and only really applies to option 3b if chosen as the solution.
- 2.4 DB also stated that with option 3b, the advantage of that proposal is that it provides DNOs with more flexibility around the primary purpose (as opposed to strictly following the TCR definitions).
- 2.5 DB mentioned that it will be beneficial to have the various options, however depending on which chosen as the solution, Ofgem will need to be prepared to step in and offer support where DNOs may face disagreements as and when needed.
- 2.6 The Chair noted that within the DCP 404/405 Q&A session, one participant queried whether a summary of how all four Access SCR CPs interlink with each other could be added within the report as this may be beneficial to the readers. It was agreed within the Q&A session that this may be better suited to the Charging Future’s Forum, however a short summary could still be added to the report for ease.
- 2.7 The Working Group are happy with how the Q&A session turned out and believe this may help with Consultation responses.

## 3. Plan for Post-Consultation

---

- 3.1 The Chair discussed the plan for post-Consultation with the Working Group.
- 3.2 The Chair suggested not going ahead with the next Working Group initially scheduled for Tuesday, 05 September 2022 as this would not provide enough time for members to review the collated Consultation responses.
- 3.3 Instead, the Chair suggested that members use the allocated time for the meeting to review the Consultation responses, add comments next to specific responses that may need to be further discussed, and then return the edited document back to the Secretariat by cop Friday, 09 September 2022.
- 3.4 The Working Group were happy with the above suggestion and agreed for the next Working Group meeting to be held on Tuesday, 13 September 2022 at 10am for DCP 406 and 2pm for DCP 407.

3.5 The Working Group discussed and agreed a list of potential outstanding items that may need to be further discussed and worked on post-Consultation. This can be found below:

- *The phrasing within the CCCM Examples document (i.e., Index Table) is not consistent and will need a clean-up – RM agreed to take an action to complete this.*
- *The ENA examples need to be updated – the Secretariat agreed to take an action to follow-up and provide the Working Group with an update. **Post-meeting update: ENA are currently working on this and plan to return the updated diagrams to us early next week (W/C 05 September 2022).***
- *A new example relating to transmission charges needs to be drafted (for Scotland) – RM agreed to take an action to complete this.*
- *Example 30 of the CCCM Examples table needs updating with the correct figures – the Secretariat agreed to complete this. **Post-meeting update: this has now been completed.***

**ACTION 16/01: RM to complete a clean-up exercise for the CCCM Examples document to ensure all phrasing is consistent.**

**ACTION 16/02: The Secretariat to follow-up and provide an update to the Working Group around the updated ENA diagrams.**

**ACTION 16/03: RM to draft a new example for the CCCM Examples document relating to transmission charges (for Scotland).**

**ACTION 16/04: The Secretariat to update the figures within Example 30 of the CCCM Examples document.**

3.6 BH queried whether it is set in stone under DCUSA whether only 2 additional alternative solutions can be provided to Ofgem along with the solution. The Secretariat agreed to seek further information around this as the Working Group agreed it would be beneficial for there to be 4 options in total (solution + 3 additional alternative solutions) and Ofgem also agreed that they would be happy to review all 4 options if allowed.

**ACTION 16/05: The Secretariat to confirm whether 4 options can be provided to Ofgem for review.**

3.7 The Secretariat agreed to circulate the collated Consultation responses to the Working Group on the morning of Tuesday, 06 September 2022 for review.

3.8 In regard to reviewing the responses, it was agreed that all members should add any comments to responses within the ‘Working Group comments’ column within the responses document (as shown in the image below), and send back to the Secretariat by cop Friday, 09 September 2022 for the Secretariat to collate into a single document prior to the meeting being held on Tuesday, 13 September 2022.
