Change Report Cover Paper

1. Synopsis

- 1.1 This paper refers any DCUSA Change Proposals (DCPs) to the DCUSA Panel for agreement on their progression.
- 1.2 This paper submits any Change Reports for DCUSA Change Proposals (DCPs) to the Panel for approval in accordance with Clause 11.20 of the DCUSA. It is noted that there are four Change Reports being presented to the Panel for approval as set out in the bullet points below:
 - **DCP 437 ‘To Shorten the DUoS Pricing Notice Periods’**
 - With respect to DCP 437, it is recommended that Parties be invited to vote on the Change Proposals (CPs) for a period of 15 Working Days.
 - With respect to DCP 437, it is recommended that the Parties eligible to vote on the CPs are those identified as Impacted Parties within the Change Report.
 - **DCP 440 ‘Consuming “De-energised” sites’**
 - With respect to DCP 440, it is recommended that Parties be invited to vote on the Change Proposals (CPs) for a period of 15 Working Days.
 - With respect to DCP 440, it is recommended that the Parties eligible to vote on the CPs are those identified as Impacted Parties within the Change Report.
 - **DCP 451 ‘Suspending Registrations’**
 - With respect to DCP 451, it is recommended that Parties be invited to vote on the Change Proposals (CPs) for a period of 15 Working Days.
 - With respect to DCP 451, it is recommended that the Parties eligible to vote on the CPs are those identified as Impacted Parties within the Change Report.
 - **DCP 453 ‘Correction to Schedule 22 – Example 7’**
 - With respect to DCP 453, it is recommended that Parties be invited to vote on the Change Proposals (CPs) for a period of 15 Working Days.
 - With respect to DCP 453, it is recommended that the Parties eligible to vote on the CPs are those identified as Impacted Parties within the Change Report.

2. Recommendations

2.1 For the above Change Reports, the DCUSA Panel is invited to:

- **NOTE** the contents of the Change Report;
- **DETERMINE** whether the Change Reports contains the level of information required to enable Parties to understand the impact of the proposed amendments and to vote on the CP;
- **DETERMINE** the Parties eligible to vote on the CP;
- **DETERMINE** the voting period for the CP, and
- **APPROVE** the Change Report for issue to Parties on 22 May 2025.
