SYNOPSIS	This document provides Parties with the Change Report for DCP 471 and the recommendation of the Parties with respect to the Change Proposal.

1. INTRODUCTION

- 1.1 In accordance with Clause 13.4 of the DCUSA this paper sets out the Parties' recommendation in respect of DCP 471.
- 1.2 The DCP 471 Change Report was issued to all DCUSA Contract Managers on 16 April 2026 for a period of 15 Working Days.

2. DCP 471 – PARTY VOTE ON PROPOSED VARIATION

- 2.1 For the majority of the Party Categories that were eligible to vote, the sum of the Weighted Votes of the Groups in each Party Category which voted to accept the proposed variation was more than 65%. Therefore, DCUSA Parties have voted to accept the proposed variation (solution).

3. DCP 471 – PARTY VOTE ON PROPOSED IMPLEMENTATION DATE

- 3.1 For the majority of the Party Categories that were eligible to vote, the sum of the Weighted Votes of the Groups in each Party Category which voted to accept the proposed implementation date was more than 65%. Therefore, DCUSA Parties have voted to accept the proposed implementation date.

4. DCP 471 – DCUSA PARTIES OVERALL RECOMMENDATION

- 4.1 DCUSA Parties have voted to accept the proposed variation (solution) of DCP 471 and accept the implementation date of DCP 471, and thus the proposed variation to the DCUSA will be made.
