MDD/ISD are managed by Elexon. MPIDs will be associated with one or more Role Codes indicating which industry roles a company undertakes.

² A DIP ID is a unique ten-digit number generated by the DIP during the DIP On-boarding process used to identify DIP Users that are not DIP Connection Providers (DCPs) when routing Messages and publications.
